Subject: PRO subscriber/Health community complaint about sponsoring of the PRO Morning Health Care by the tobacco industry.

Dear Ms Fluet and Ms Gessner,

On behalf of the Association of European Cancer Leagues (ECL), a non-profit European umbrella organisation of national and regional cancer societies, a long-term user of Politico PRO service, and the undersigned organisations, **we would like to raise a concern of the recent sponsoring of Politico's newsletters, particularly Politico PRO Health Care, by the tobacco industry (namely British American Tobacco, BAT), which occurred in the week of 24 June 2019.**

With this letter, the undersigned organisations ask Politico to reject any form of advertising of tobacco companies as unacceptable, in regard to credible health reporting.

Tobacco is the single most important risk factor for cancer (and other diseases), responsible for over 30% of cancer burden in Europe. Since 1990s, ECL has been a strong advocate in favour of a tobacco advertising ban, because it could not accept the promotion of a product which kills at least half of its customers.

Belgium has a very strict ban on tobacco advertising (the law of 10 December 1997). This law also applies to advertising for e-cigarettes, classified as similar products. The legislation is very strict as the tobacco industry had been circumventing rules on advertising for more than two decades. In fact, the definition of advertising in Article 3 of the Belgian law is broad enough to exclude any actual or future loophole introduced by big tobacco. ¹

In our opinion, there is no doubt that the sponsorship by British American Tobacco (BAT) of the Politico PRO Health Care is an infringement of the Belgian legislation and we would call on you not to accept any sponsorship by tobacco companies in the future.

Moreover, we see this as an infringement of the Article 13 of the FCTC Protocol, stating that *'Promotion of tobacco companies themselves (sometimes referred to as corporate promotion) is a form of promotion of tobacco products or tobacco use, even without the presentation of brand names or trademarks.'*² The EU ratified the protocol on 24 June 2019.

Therefore, we, the European health community, ask Politico to reject any form of advertising of tobacco companies, as this is unethical and unacceptable from our perspective as well as in order to retain Politico's credibility in health reporting.
